The application and the supporting documents are reviewed by the Joint Director. In case of any queries in the application form or supporting documents, queries shall be raised by the Joint Director through the SWP within 3 days from the receipt of documents. In such cases, the applicant shall respond to the queries through the SWP. Based on the decision, the application is approved/ rejected and the registration certificate is sent to the applicant through the SWP.
